



## RENTAL CONDITIONS – RANGER4RENT

- This rental agreement is made between Hero Caper ApS and the tenant.
- Entering this agreement, the tenant agrees by an inspection of a rented Hero Camper, that it appears without any damage by delivery, etc., and subsequently is handed over to the owner again after the rented period. The agreed rental period is stated in the contract where the payment obligation also will appear. all prices are stated without VAT.
- Unless otherwise agreed in the contract between owner and tenant, pick up and returning must be at the owner's address in Esbjerg, DK.
- In case of any delayed returning or pick-up of the Hero Camper, the tenant must pay additional rent for the period of delay, which is **EUR 34,-** pr. Hour.
- By cancellation 30 days before the lease period takes place, refund will be the rental amount minus 25%. By cancellation between 29- and 15-days before lease period, refund will be the rental amount minus 50% By cancellation 14 days or less before lease period, the full amount is withheld. The deposit will be refundable. Deposit is paid in accordance to the contract agreement and is to be refunded within 10 working days after returning the rented Hero Camper.
- The Hero camper is insured for rental use. However, the tenant is fully liable for any damage not covered by this specific insurance, even if a dog brought along and causes any damage to the Hero Camper. The exemption will be **EUR 336,-** per. Damage. If an accident is incurred by the tenant during this rental agreement, the owner cannot be held responsible by any costs.
- Due to default, and a Hero Camper is not available to new tenants at the agreed time, the owner cannot be held responsible. However, in this case, the new tenant can terminate the agreement immediately and is entitled to receive the full amount back.
- It is allowed to bring 1 Dog at an additional cost of **EUR 81,-**. It is not allowed to leave the dog alone in the Hero Camper or in the awning unattended. (Mattress needs to be covered with linen before Dog entering the camper).
- Smoking in the Hero Camper and in tents is strictly forbidden.
- The Hero camper is only to be used for the number of people it is intended for and the tenant must document that he / she has a valid driver's license.
- The tenant is responsible for any damages that occur during the rental period. The owner cannot be held responsible for any Tenant's loss due to lack or defects on the Hero Camper.



- The Hero Camper as well as any inventory rented must be returned to the owner at the agreed time and in the same condition as when delivered. When returning the Hero Camper, it must be cleaned inside. Tenant must ensure that Tents and awnings are clean and dry as well.
- If the Hero Camper is not cleaned when returning, the tenant will be held responsible and have to pay a fee of **EUR 93,-** which will be deducted the deposit.
- The lease contract is subject to the Danish law. Any dispute, that may arise in connection with the lease must be settled by an ordinary court. The parties declare that they have understood the rules described in the "Contract Act", "the Consumer Agreement Act" and "the Purchase Act".
