## RENTAL CONDITIONS – HERO CAMPER RENTAL

- The lessor hereby confirms that he is the owner of the Hero Camper stated in the rental contract and will make it available to the lessee during the agreed rental period.
- The renter signs that the standard of the rented Hero Camper on the handover day, after a joint inspection, appears beyond doubt for any damages, etc., when it is subsequently returned to the lessor after the end of the lease.
- The agreed rental period is specified in the contract. If an agreement is concluded, the first installment is due when booking a Hero Camper. A Hero Camper is only considered reserved when the agreed amount has been received.
- Cancellation up to 30 days before the lease takes effect, the amount paid minus 25% of the full rental amount is refunded. In case of cancellation between 29 and 15 days before the tenancy comes into force, the amount paid minus 50% of the full rental amount and the full deposit will be refunded. In case of cancellation later than 14 days before the tenancy comes into force, no rental amount is paid back, however the full deposit is refunded.
- Hero Camper and equipment must be returned to the owner's residence at the appointed time and in the same condition as when received. Without prior agreement, **EUR 34,-** will be charged per hour for late collection or delivery.
- If the Hero Camper is not available to a new renter at the agreed time due to a previous renter's default, the landlord is not responsible for this. In this case, however, the new tenant can terminate the agreement immediately and is entitled to receive the full amount back.
- Deposit and rent are paid in accordance with the contract agreement applicable at any time and the deposit is refunded no later than 10 working days after the return of the rented Hero Camper.
- The Hero Camper is insured for rental. The owner has taken out comprehensive insurance. The renter is fully liable for any damage that is not covered by this insurance, even if the dog brought along causes damage. The deductible amounts to **EUR 336,-** per damage that is covered by comprehensive insurance.
- In the event of an accident, any expenses incurred by the renter during the rental will be beyond the control of the landlord.
- It is allowed to bring 1 Dog at an additional cost of **EUR 81,-**. It is not allowed to leave the dog alone in the Hero Camper or in the awning unattended. (Mattress needs to be covered with linen before Dog entering the camper).
- Smoking in the Hero Camper and in tents is strictly forbidden.
- The driver of the car is only the renter or other named person listed in the contract and may only be used for the number of people it is intended for. The renter documents that he/she has a driving license and that he/she has the necessary knowledge to drive a camper (referred to here as Hero Camper).

- It is the renter's responsibility that the rented Hero Camper can be towed by a car that is allowed to tow a camper and specified weight classification.
- The renter is responsible for damages that occur during the rental period. The lessor is not responsible for damage caused when renting a Hero Camper. Furthermore, the Lessor is not responsible for the renter's possible losses due to deficiencies or defects in the Hero Camper.
- The camper must be cleaned inside and vacuumed. The tent and awning must be clean and dry. In case of lack of cleaning, max. **EUR 93,-** in deposit to cover.
- The lease contract is subject to the Danish law. Any dispute, that may arise in connection with the lease must be settled by an ordinary court. The parties declare that they have understood the rules described in the "Contract Act", "the Consumer Agreement Act" and "the Purchase Act".
